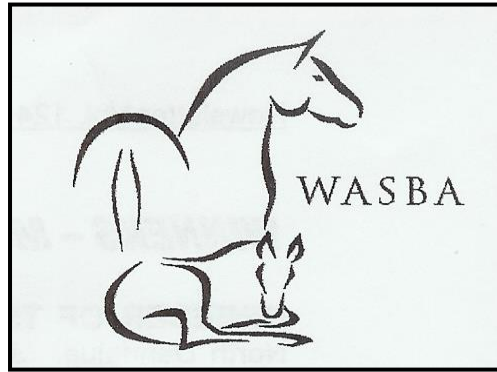

CONDITIONS OF ENTRY

It is a condition of entry that all competitors, whether engaged in any event or not, do so at their own risk and will indemnify and save harmless the organizing club, committee members and members from all claims, actions, suits or demands arising out of injury, personal or otherwise caused out of their presence at this show. **Disclaimer Statement forms to be completed and sent back with prepaid entries.**

The organizers of the show have the right to refuse entry to any person, or to demand the immediate departure of anyone considered to be behaving in an unsuitable manner. Exhibitors, Competitors and spectators are expected to read and adhere to the [SPPHAWA Show Rules & Policies](#). IT IS UP TO EACH EXHIBITOR TO ONLY TAKE HORSES THAT ARE IN GOOD HEALTH.

THE COMMITTEE RESERVES THE RIGHT TO ALTER THE PROGRAM WITHOUT PRIOR NOTICE.

Please Note - There will be NO Food available so please plan accordingly and BYO.

Led Presentation: all horses must be presented in a show bridle with reins or lead. Halters are not permitted for led classes. Plating is optional for Colts/Stallions, Juniors or any Sporthorse discipline that does not require plaiting of horses. Mares and geldings must have plaited/hog manes with tails plaited, shaved or pulled. Stallions must be bitted and handler carry a whip at all times. **No junior is permitted to ride, handle or be responsible for the care of a Colt\Stallion.** Whips are not to be used in handler classes and must not exceed 120cm.

Handler Presentation: Handlers must be dressed in suitable attire to run and handle a horse. No see-through or revealing clothing to be worn. Preferably suits, pants or skirt, shirt/blouse, a suitable dress or ridden attire with a hat and gloves. Fully covered shoes must be worn, jeans and joggers are not permitted.

Ridden Presentation of Horse & Rider: Horse presentation is that of Led horses with the exception that all horses must be plaited. Jacket, stock/tie, vest, breeches, boots, gloves should be clean and color coordinated to match horse. Helmets must comply with current EA Showhorse guidelines. Junior riders are not permitted to use long boots in their rider classes. Whips must not exceed 75cm. Number holders are optional but preferred.

Ridden Grading – Please read Page 7 of [SPPHAWA Show Rules & Policies](#) for further details.

Walk/Trot Ridden Horses: All Standardbreds are graded as Walk\Trot eligible until such time they have competed at SPPHAWA events for longer than 12 months and won 3 Champions. IF you have competed in ANY CANTER class at **any event** you are no longer eligible to compete. This includes eventing & dressage(Excluding Prep 3)

Intermediate Ridden Classes: For all horses coming out of the Walk/Trot ring or any horse in the first years competing at canter level. These horses should show a degree of softness throughout the gaits and be capable of executing canter on either rein. It is expected some of the horses will be quite green but we encourage people to move their horses up into this section to gain experience. Should a Walk/Trot graded horse compete in this class, they will not be eligible to drop back to Walk Trot at a later date. Horses competing in Intermediate classes are not to wear Double or Pelham Bridles and are to be ridden in a snaffle bridle. A judge has the right to ask an exhibit to leave the ring if deemed to be working in an unacceptable manner.

Open Ridden: Is only for horses that have been approved and upgraded by the Committee. These horses consistently work at the desired level of education that all Standardbreds should be striving for. If your horse is assessed as successfully demonstrating these qualities throughout the season you will be advised by email deeming your upgraded status. Any Open graded horse is permitted to wear a Double or Pelham style Bridle.

Notes for entering Classes:

Best Presented Classes – all winners of Best Presented classes are eligible to contest the Champion Best Presented Exhibit at the end of led judging. Any second-place getter is eligible to contest for Reserve if the winner of your class wins Champion.

Led Maiden – for any horse that has not won a **FIRST PLACE** at the SPPHAWA State Championships, Dual Code or Scorecard Showdown. Excluding Best Presented, Led Show Horse, Led Show Hunter, WA Bred, Track To Hack or Handler classes. Also eligible to compete in all other sections.

Led Classes – you can only compete in one section. **Junior, Sporthorse or Senior Genders.** Classes 4, 5, 6, 8, 10, 11, 13, 14, 15, 17 & 18 will be judged using the scorecard format with Supreme, Champion, Reserve and Placings awarded on a highest score. Scorecards can be viewed after the event by emailing entries@spphawa.com.au

Sporthorse Class – this class is specifically for horses that compete in 'other' disciplines e.g Racing, Jumping, Eventing, Endurance, CDE. Proof of performance in the past 45 Days must be provided (results listing from such event) with entry forms. **You cannot enter any other Led Section – Junior, Stallion, Mare or Gelding.** Horses competing in this led section are eligible to compete in the ridden class for Intermediate & Open.

Track To Hack – these classes are for horses who have **raced or trialed** in their lifetime. Proof will be required with entry. A race history can be downloaded from the HRA Website – select Racing / Horse Search. You can search by racing name or brand.

WA Bred – these classes are for horses that were bred in Western Australia. If you are unsure this can also be viewed on the HRA Website.

Led Show Hack/Show Hunter classes – you can only compete in one section in the show hack/show hunter in the miscellaneous led, not both. Please select the class that best suits your horse.

Ridden Classes – Horses must compete in led classes to be eligible for ridden classes.

Ridden Show Hack/Show Hunter/Sporthorse classes – you can only compete in one section in the ridden Show Hack/Show Hunter or Sporthorse class. Please select the class that best suits your horse.

Novice Walk/Trot – horses must not have won more than 3 first places at a SPPHAWA major event (State Championships, Dual-Code, Scorecard)

Newcomer Intermediate – for horses who are in their first 12 months of competing in the Intermediate grade. Not eligible for Supreme.

A NO REFUND POLICY WILL APPLY UNLESS THIS EVENT IS CANCELLED

ALL ENTRIES MUST PROVIDE AN OTT PASSPORT

SWABBING MAY TAKE PLACE – PLEASE ENSURE YOU HAVE YOUR REGISTRATION CARD (IF SPPHAWA REGISTERED) OR A PRINTOUT OF YOUR HORSES DETAILS FROM THE HRA SITE. NO CHAMPION EXHIBIT CAN LEAVE UNTIL THE SWAB DRAW HAS BEEN COMPLETED

WHISKER REMOVAL RULING

Any competitor who presents a Standardbred to any class will be rejected entry to the ring if this ruling has been breached. It will be a condition of entry provided on the program that will be signed by the exhibitor that you will abide by any SPPHAWA ruling. No refund will apply if entry to compete is denied

Annual Risk Warning and Waiver of Liability – Non Members Only

The following pages affect your legal rights and obligations. Please read these carefully and only sign if you fully understand their contents. For Participants under 18 years of age, these documents must be completed by a parent or legal guardian.

Description of Activities¹: Any equestrian event that is run by SPPHAWA

Risk Warning

I am aware that by my participation in any activities arranged by the Provider, certain risks or dangers may occur which could include:

- Physical, bodily or psychological injury or death.
- Physical exertion to which I am not accustomed.
- Failure of equipment or use of inadequate equipment.
- There may be no or inadequate facilities for treatment or transport to treatment if I am injured.
- The conditions in which the activities are conducted may vary without warning.
- I may cause injury to other persons and/or other persons may cause injury to me.
- I may be injured or die due to the negligence, breach of contract or breach of statutory duty or guarantee of the provider.

I acknowledge that the activities are being undertaken for the purposes of recreation, enjoyment or leisure, and involve a significant degree of risk of physical harm. I acknowledge that the Activity may be undertaken with one or more other persons as part of a group and that the Provider is not liable for the actions of other participants in the group activity.

By signing below, I acknowledge, agree and understand that the risks associated with the Activities and/or recreational services have been explained to me. I undertake any such risk voluntarily and at my own risk.

I acknowledge that the risk warning above constitutes a "risk warning" in accordance with the *Civil Liability Act 2002* (NSW) and the *Civil Liability Act 2002* (WA).

Participant's Warranties

I agree to abide by any of the Provider's rules, and any direction or instruction given to me by the Provider during the course of the Activities. I agree to use and/or wear any equipment given to me by the Provider.

I declare that I am medically and physically fit and able to participate in the Activities. I acknowledge that I must, and agree that I will, disclose any pre-existing medical or other condition, injury or concern that may affect the risk that either I or any other person will suffer injury, loss or damage during the course of the Activities and notify the Provider of any injuries, illness or concerns that may arise during the Activity. I will not engage in any reckless, negligent or foolish behaviour or any other behaviour that is likely to cause injury to me, any other participant or person.

I agree that if I suffer any injury or illness, the Provider may provide evacuation, first aid and/or medical treatment at my expense and that my acceptance of these terms and conditions constitutes my consent to such evacuation, first aid and/or medical treatment.

I declare that I have not consumed any alcohol or mind altering substance, or medication that may impact my judgement or physical capacity, before or at the time of engaging in the Activities.

Exclusion of liability

I agree to and unconditionally release, waive, discharge and forever hold harmless, the Provider or any of its employees, agents, directors or officers, from any claims as a result of any personal injury sustained, whether caused by the Provider's negligent act or wilful act or omission, breach of contract, breach of statutory duty, error, or otherwise in connection with or arising out of the Activities.

I agree that the Provider will not be liable for any claims for personal injury that may be brought against it as a result of or in connection with any act, omission, default, failure or error on the part of the Provider, and agree to indemnify and keep indemnified the Provider in respect of any such claims.

Waiver

It is possible for a supplier of recreational services to ask you to agree that the statutory guarantees under the *Australian Consumer Law* (which is schedule 2 to the *Competition and Consumer Act 2010* (Cth)) do not apply to you. If you sign this form, you will be agreeing that your rights (or the rights of a person for whom or on whose behalf you are acquiring the services) to sue the Provider in relation to the Provider's services or the activities that you undertake because the services or activities provided were not in accordance with the guarantees are excluded, restricted or modified as set out below.

For Queensland, New South Wales, Western Australia, Tasmania, Northern Territory and Australian Capital Territory and Commonwealth

By signing this form, you agree that the liability of the Provider in relation to the activities (as defined by the *Competition and Consumer Act 2010* (Cth), the *Consumer Affairs and Fair Trading Act* (NT) and the *Australian Consumer Law*) and recreational activities (as defined by the *Civil Liability Act 2002* (NSW) and the *Civil Liability Act 2002* (WA)) for any:

- Deaths;
- Physical or mental injuries (including the aggravation, acceleration or recurrence of such an injury);

You acknowledge and agree that the above provision operates to exclude the liability of the Provider as a result of a breach of an express or implied warranty that the recreational services will be rendered with reasonable care and skill in accordance with section 5J of the *Civil Liability Act 2002* (WA) and section 5N of the *Civil Liability Act 2002* (NSW).
