- In the event of extreme weather (40°C plus) the organizers will cancel the event and full refunds will be given
- The Committee of the Swan View Agricultural society reserves the right to **cancel, alter or combine any classes they may deem necessary on the day.**
- All competitors under the age of 18 must be accompanied by an adult to be eligible to compete.
- **Colts and Stallions may only be shown by a handler 18 years and over and wearing suitable headgear with a green disc clearly visible.** This will alert other competitors of your exhibits status.
- Disclaimer statements must be completed by Owner/Exhibitor
- **All handlers must be suitably attired. Shoes must cover the instep, no ballet pumps or trainers.**
- Any exhibit leaving the ring will be disqualified.
- All exhibits must be registered with their breed Society (excepting TB/St.bred) and handlers must become day members of Swan View Ag Soc.
- The Swan View Agricultural Society committee and its' agents, representatives, promoters and organizers do not accept any liability due to accident, loss, damage to property, injury or illness to horses, exhibitors, spectators or any other person whatsoever.
- The Judges' decision is final. Protests must be received within 30 minutes of the conclusion of the event, in writing with a \$50 fee to be refunded only if the protest is upheld.
